## All Competitors/All Competitions: Recognition in meeting minutes and/or social media

\*\*Because NAFSC cannot monitor every competition and every result, it will be the responsibility of the skater/parent to notify us of competitions/placements in order to keep information as up to date as possible.

## National Qualifying Series Competitors(Qualifying Competitions Only):

- Entry fee reimbursement<sup>1</sup> for one NQS competition at annual awards celebration
- Recognition at annual awards celebration

## Eastern Sectional Competitors (Qualifying Competitions Only):

- Recognition at rink, on website, and on social media
- Press release to local newspaper(s)
- Good luck letter from NAFSC
- Potluck send-off and exhibition time at send-off
- Entry fee reimbursement<sup>1</sup> at annual awards celebration
- Fruit/flowers from NAFSC at event<sup>2</sup>
- Recognition at annual awards celebration

## Placing Eastern Sectional Competitors (Qualifying Competitions Only):

- Congratulatory letter from NAFSC
- Press release to local newspaper(s) with event and placement
- Cash stipend of \$100.00 for each placing event<sup>2</sup>

## U.S. National Championships Competitors:

- Recognition at rink, on website, and on social media
- Press release to local newspaper(s)
- Good luck letter from NAFSC
- Potluck send-off and exhibition ice time at send-off
- Fruit/flowers from NAFSC at event<sup>2</sup>
- Recognition and \$250 award<sup>1</sup> at annual award celebration

## Placing U.S National Championships or Junior Olympic Competitors:

- Congratulatory letter from NAFSC
- Club Recognition such as display poster, website recognition, etc. (to be determined)
- Press release to local newspaper(s) with event and placement
- Cash stipend of \$1,000.00 for each placing event<sup>2</sup>

## Adult U.S. National Championships:

- Name and bio on poster display
- Press release to local newspapers(s)
- Good luck letter from NAFSC

- Potluck send-off and exhibition ice time at send-off
- Entry fee reimbursement<sup>1</sup> at annual awards celebration
- Recognition at annual awards celebration

Adult U.S. National Championships Competitors:

- Congratulatory letter from NAFSC
- Press release to local newspaper(s) with event and placement
- Cash stipend of \$50.00 for each placing event<sup>2</sup>

<sup>1</sup> Reimbursement/award guidelines are outlined in Regional Fund usage policy. In order for skater to qualify for reimbursement, skater must be a home club skater, must compete on behalf of NAFSC in a qualifying regional/sectional event, buy NAFSC ice, maintain a local coach, and participate in NAFSC activities. Associate members and non-members are not eligible for this reimbursement/award.

<sup>2</sup> Cash stipends & fruit/flowers will be awarded to NAFSC home club competitors. Skater should be a member in good standing, must compete on behalf of NAFSC, buy NAFSC ice, maintain a local coach, and participate in NAFSC activities. Associate Members who train on NAFSC ice will be awarded non-expenditure recognition.
